#### **Dual Membership or Petition for Affiliation Fee**

# **Dual Membership Petition or Petition for Affiliation shall be accompanied by:**

- **1**. \$3.00 if from a chapter in a foreign jurisdiction (out of the State of Washington). *The Chapter keeps this fee do not send it to Grand Chapter.*
- 2. Per Capita Fee, as listed above.
- **3**. Balance of the chapter's dues pro-rated to March 31<sup>st</sup>.
- **4**. International Headquarters Fee (\$5.00).

# Reinstatements

C&BL Sec. 1403

# 1. Within 25-months of being dropped individual should pay:

- **a**. Amount due at the time of being dropped.
- **b**. Dues for current year (pro-rated to March 31<sup>st</sup>).
- c. Per Capita Tax:

# 2. After 25-months of being dropped individual should pay:

- **a**. Dues for the current year, pro-rated to March 31<sup>st</sup>.
- **b**. Per Capita Tax (see chart above).

**IMPORTANT:** Only the International Headquarters Fee is sent to the Grand Chapter office upon initiation of a new, dual or affiliated member. The Per Capita is billed once a year in April.

**IMPORTANT:** This information is based on the Constitution and By-Laws. There may be other fees that the chapter charges – that is strictly up to the chapter's discretion.

**IMPORTANT:** A reinstated member does not pay the International Headquarter Fee.
